'Office space leasing drops 50% in Sept qtr'

New Delhi, October 5

NET LEASING OF office space fell 50% across seven major cities to 5.4 million sq ft in the July-September quarter as corporates and coworking players continued to defer their expansion plans due to the Covid-19 pandemic, according to property consultant JLL India.

The net absorption of office space stood at 10.9 million sq ft in the year-ago period across 7 cities — Delhi-NCR, Mumbai, Kolkata, Chennai, Pune, Hyder-

abad and Bengaluru.

During January-September 2020, the net office space leasing dropped by 47% to 17.3 million sq ft from 32.7 million sq ft in the corresponding period of the previous year.

"India's office market witnessed a net absorption of 5.4 million sq ft in quarter ending September 2020 (Q3), an increase of 64% versus quarter ending June 2020 (Q2)," JLL India said in a statement.

During July-September, Bengaluru was at top with net leasing of 2.72 million sq ft.
